Sub: Letter of Permission for B.Sc Nursing courses at "Brahmaputra College of Nursing, Tetelia, under Geanjyoti National Foundation"

Sir,

With reference to the subject cited above, I am directed to say that the Government of Assam in Medical Education & Research Department hereby grants Letter of Permission (LoP) to Brahmaputra College of Nursing, Tetelia, under Geanjyoti National Foundation.

This Letter of Permission is subject to the following conditions:

- 1) The LoP (Letter of Permission) does not amount to the grant of permission for admissions, which will be granted by the affiliating University as prescribed under the respective rules and regulations.
- 2) The institution shall ensure compliance with all the requirements with regard to physical infrastructure, clinical facility and teaching facility as laid in affiliated University guidelines, respective council and as per the Regulatory framework notified vide.no.MER.206054/786 dated 7th November, 2023.
- The institute is to adopt a competency-based curriculum formulated by the respective councils, incorporating subjects like English Communication, a foreign language, professional ethics, skill development, and computer knowledge as specified in the Regulatory framework.
- 4) The institution must ensure implementation of periodic continuous education programs for faculty members in both government and private institutes, with content, duration, and assessment methods prescribed by the respective councils.
- 5) The institute must ensure compulsory pre-registration internship for B.Sc. Nursing, similar to the MBBS students, with a one-year internship requirement.
- 6) The institute will have to obtain a separate No Objection Certificate for each academic session as per Regulatory framework notified vide. no.MER.206054/786 dated 7th November, 2023.

7) Periodic reviews will be conducted by Government to verify compliance with all requirements by the institute.

8) The institute will furnish an agreement with the affiliated/ parent hospital for clinical exposure as required under affiliating University and Government guidelines which will clearly state that such an arrangement will not exceed prescribed ratio, in order to avoid overcrowding and therefore inadequate clinical exposure of students as well as deterioration of patient care in the hospital.

a. This document will be furnished to Government within a month of issue of LOP by State Government with copies to DME and affiliated

University.

9) The Institution will communicate the major decisions of the management

regarding fees,etc to the Govt. on regular basis

10) Copies of the reports of any inspection by any authority carried out from time to time will be submitted by the Institute to this Department and the affiliated University immediately.

11) The institution shall obtain approval and affiliation from SSUHS and send

copy of the same to Government.

12) The institute shall not admit any student, prior to obtaining affiliation of the courses by SSUHS.

13) The institute shall not admit more students, other than the approved capacity.

14) The Government may impose any other condition(s) at any time, which shall be binding on the institute.

15) Failure to comply with the above conditions will lead to withdrawal of the Letter of Permission and legal action deemed fit shall be taken against the institutions.
